



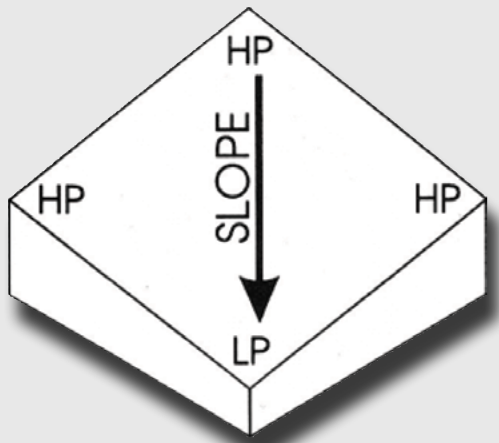
ICA-HIPS & ICA-VALLEYS

Roof Insulation

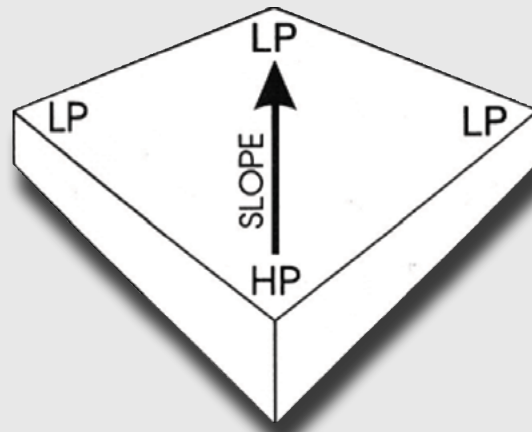
ICA

ICA-VALLEYS and ICA-HIPS are 4 foot by 4 foot panels which are cut to conform to a standard 45 degree line. ICA-VALLEYS have three high points and one low point for a valley line sloping downward and ICA-HIPS have three low points

and one high point for a hip line sloping upward. These mitered corners save the applicator valuable time and money by providing a quick installation of the tapered panels.
