► Do It Yourself

- ICA-PAK paneling insulation is pre-cut to fit between your wall or attic stud system.
- Helps reduce heat loss and condensation problems in basements, dens and offices.
- Gives paneling support and reduces impact damage.
- Installed quickly with common hand tools.
- High R value—economical.
 - 1 lb. density “R” = 2.9
 - Low density “R” = 2.5
- Easily fastened with adhesive or mechanical support.

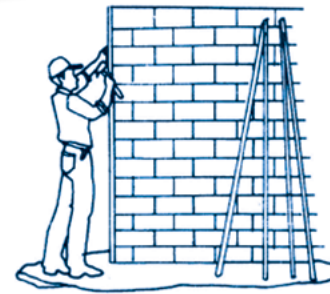
► Easy to Install

- Install horizontal furring strips along the floor and ceiling.
- Nail vertical furring strip in corner and continue nailing furring strips every 16" on center. (It's easier to use the paneling insulation as a spacer.)
- Place ICA-PAK insulation between furring strips to insure tight joints, use a sharp knife for trimming.
- Fasten 1/2" gypsum to furring strips with nails or fasteners recommended by gypsum supplier. (Gypsum must have a finish fire rating of 15 minutes or more.)
- Panel or Paint

► Packaging

- Each package of ICA-PAK contains six pieces of 3/4" x 13-5/8" x 48". When installed with furring strips, it will cover 32 square feet. It is shipped 12 packages to a bundle.

NOTE: Use adhesive manufactured for use with polystyrene. Expanded polystyrene (EPS) is combustible and should not be exposed to flame or any ignition source.
